RE-LIVE THE SUFFRAGE MOVEMENT

Sun. Feb. 10, 2013, 2:00 pm. **Falls Church Community Center** Historic re-enactor Lynne Garvey-Hodge will present a one-woman monologue about the fight to obtain the vote for women, through the story of a wealthy Baltimore woman, Mrs. Robert Walker, who became a suffragist. Mrs. Robert Walker (aka Amelia Himes), joined the suffragist movement and in 1917 was one of over 100 women who were arrested in front of the White House and incarcerated at the Occoquan Workhouse. Mrs. Robert Walker, born into a world of privilege in Baltimore, graduated from Swarthmore College at a time when few women were educated. The monologue tells the story of how she was transformed into a suffragist, her arrest in front of the White House in the summer of 1917, her incarceration at the Occoquan Workhouse for 60 days, and the Prison Parades in 1918-19. After the vote for women was obtained. Walker continued to lobby for women's rights; later in life she participated in presentations to Congress for the Equal Rights Amendment. Lynne Garvey-Hodge is a member of the Fairfax County Historical Society.

FROM THE BOARD

The Board met for its regular meeting on January 28th. The main focus of the meeting was a review of recommended bylaws changes from the Bylaws Committee, Martha Trunk and Pam Martinov. With the input from the Board, the bylaws are ready for presentation and distribution to the membership at the Feb. 10th meeting. We will vote on the amendments to the bylaws at the Annual Meeting on Monday, March 11th.

VP for Programs reviewed the plans for the remaining branch meeting for the year. It was suggested that we have a former scholarship recipient speak at the May Scholarship Meeting. Sharon asked for suggestions of inexpensive restaurants where we can seat a big crowd for the End-of-the-Book-Sale dinner. Last year the dinner was at Panshir in Falls Church.

Membership Co-Chair Dianne Bodeen reported that she would like to make an attractive, informative permanent tri-fold poster about AAUW that could be used by members at the Book Sale and a variety of other settings. She and Becky Gaul will develop this poster and bring it to the Board for review.

Treasurer Stasia Gifford indicated that she will have a report of expenditures to date and a proposed 2013-2014 budget for review by the board at their February meeting. The membership will vote on the budget at the March meeting.

There was consensus among the Board members that the required Annual Reports will be submitted in June during the last month of the fiscal year rather than at the Annual Meeting in March. This will enable officers and committee chairs to include all activities of the year in their reports.

Mollie Jewell announced the Book Sale Organizational Lunch for February 16th at Mary Youman's house. Detailed information about the Book Sale is published in this newsletter. Mollie will pursue contacts with George Mason High School and Northern Virginia Community College to involve students in the Book Sale with the possibility of getting an intern to serve with the Book Sale chairs for the entire year next year.

Becky Gaul reported that she has had conversations with staff at the national AAUW office, and was assured that we can get our scholarship application online using their system. Becky will continue to pursue revision of our website with the new AAUW logo to be released in February and additional tools from the national office.

The branch must elect the Vice President for Membership and the Treasurer at the Annual Meeting in March. These two officers are elected in odd years with the remaining officers elected in even years. Dianne Bodeen was appointed chair of the Nominating Committee. Bunny will appoint two other members of the committee with the consent of the Board.



SUMMARY OF JANUARY BRANCH MEETING

Below is a summary of the actions taken by the membership at the January 13th Branch Meeting. Remember that the book sale and scholarship reports were emailed to members before the meeting. If you need a copy, please contact Bunny, and she will resend it.

Book Sale Operations Task Force: The report of the Task Force was

unanimously approved.

Local Scholarship Committee Report: 2012 Process, Concerns and Recommendations.

The Purpose Statement of the Falls Church AAUW Educational Equity Scholarships was unanimously approved. The recommendation that at least one scholarship be awarded to a qualified girl from each of the high schools submitting applications was unanimously approved. Consensus was reached that, given the adoption of the Dream Act and AAUW's commitment to equity, there should be no requirement for citizenship of the scholarship applicants.

Report of Board Recommendations for Unreimbursed Expenses: A motion to increase our Branch Budget by \$500 a year to cover Administrative Costs of the Branch in the following categories: General Administration, Membership, Programs, and Outreach was unanimously approved. A motion to require that members receive authorization from the Board prior to incurring expenses over \$20.00 was unanimously approved. A motion to move \$500 from the Book Sale Account to the Branch Account at the beginning of the fiscal year July 1, 2013 was unanimously approved. It was understood that reimbursed and unreimbursed expenses would be

monitored closely during 2013-2014 to determine if the \$500 meets our needs. A detailed budget report for the 6 months ending December 31, 2013 will be used in creating the budget for the following year to be voted on by the membership in March 2014.

WE HAVE MONEY TO AWARD TO COMMUNITY ORGANIZATIONS!

The Board recently approved two Special Projects grants, each for \$500. One was to support a Teenstretch afterschool program; the other was tuition support for a Homestretch nursing student in her last semester at NOVA.

The deadline for Special Projects applications is March 31st. We currently have approximately \$1600 in the Special Projects budget to be awarded this year. MEMBER NEWS

NORTHERN DISTRICT NEWS

George Mason College/University Partner got a big boost when Kitty Richardson and I met with the directors. associate director and graduate students at the Office of Diversity, Inclusion and Multicultural Education and the Office of Women and Gender Studies in December. We discussed activities within AAUW at all levels and the many resources in the DC metro area that could be tapped. For the spring semester, we are looking at activities such as involvement with Lobby Corp, having a presentation from Turning Point Suffragist Memorial, sponsoring students to attend NCCWSL, and publicizing e-student membership.

Sexual Assaults in the Military. The Academy Award nominated Invisible War and the high profile lawsuits LAF has supported have influenced the 2013 National Defense Authorization Act (NDAA). The NDAA has 19 amendments that reform sexual assault/harassment policies, including: •Prohibit the military from recruiting anyone convicted of a sex offense •Mandatory separation of convicted sex offenders

•Create a "Special Victims Units" to improve investigation, prosecution and victim support

•Create an independent review panel to closely examine the way that the DoD investigates, prosecutes, and adjudicates sexual assaults However a recommendation to change how rapes are reported and prosecuted was not acted on. Currently reports must go through the service member's chain of command. The Sexual Assault Training Oversight and Prevention Act, which AAUW supports, calls for rape cases be tried in civilian rather than military courts. DoD opposes this change as it would disrupt "good order and discipline."

VIOLENCE AGAINST WOMEN ACT

A bipartisan group of senators have reintroduced the Violence Against Women Act (VAWA). This is essentially the same bipartisan bill that the Senate passed in April 2012 to improve VAWA programs and ensure all victims get the services they need. Because the House didn't pass this version before the end of 2021, we must renew our efforts to day to protect victims of domestic violence. Since its enactment in 1994, VAWA has saved both lives and money. The programs continue to run even though the current authorization expired almost two years ago. Senate bill 47 is a well-crafted bill with strong bipartisan support which includes campus safety provisions which will ensure that institutions of higher education have comprehensive procedures in place to address domestic violence, dating violence, sexual assault, and stalking. Contact your senator today to cosponsor this bill and move it forward.

PAYCHECK FAIRNESS ACT

One of AAUW's top priorities for the 113th Congress is the Paycheck Fairness Act which would deter wage discrimination by closing loopholes in the Equal Pay Act and bar retaliation against workers who disclose their own wages to co workers, Without this bill, employers can penalize and even fire employees for talking about their salaries. This practice leaves workers in the dark, preventing them from ever finding out about pay discrimination in the workplace. We can't make real progress in closing the wage gap until we strengthen enforcement of existing anti-discrimination laws and give women the tools they need to get the pay they deserve. Contact your Senators and Representatives to urge them to cosponsor this important legislation.
