The Board did not meet during April or May due to the heavy schedule of activities of the Book Sale and the Scholarship Meeting. Business of the board was accomplished via email as needed.

The Board met for the last meeting of 2013-2014 on June 17, 2013. Newly elected officers were welcomed to the Board: **Kitty Richardson-**Membership Vice President and **Martha Trunk-**Treasurer. Thanks to Kitty and Martha for stepping up to fill this critical jobs.

Programs: Sharon Zackula reported that the Planning Picnic on June 17 was a big success. Many new and continuing members socialized and ate good food. Sharon reported that she has received many Program Topic Surveys from the Planning Picnic and from the emailed survey sent to members. This film explores the epidemic of rape and sexual assault within the ranks of the US military. An American female soldier in a combat zone is more likely to be raped by a fellow soldier than killed by enemy fire. A culture of impunity has resulted in few prosecutions and the isolation of women who report the crimes.

NORTHERN VIRGINIA PLANNING MEETING, JUNE 29, 2012

Our branch was represented at the Northern Virginia Planning Meeting by Bunny Jarrett, Sharon Zackula, Kitty Richardson, and Elizabeth Kessel. Participants divided into three groups to discuss identifying branch leaders, recruiting new members, and co-sponsoring branch meetings. Many useful ideas were generated which our representatives will share during the coming year. Attendees from other branches were especially interested in how we were able to recruit 13 new members this year. CURRENT ISSUES AND ACTIONS

PAY EQUITY

Louisiana Equal Pay Act Signed

AAUW Convention attendees from around the country joined their fellow AAUW members in Louisiana in calling Gov. Jindal to sign the Equal Pay for Women Act – and our hundreds of calls worked! Recently Gov. Jindal signed the bill into law, making it the state's first gender pay equity law. Congratulations to AAUW of Louisiana advocates on this important victory, and thank you to everyone who joined them in the final stretch of this push!

New York State Assembly Passes Women's Equality Act

The hard work by AAUW of New York State and its coalition partners paid off Thursday with the state Assembly's <u>passage</u> of the Women's Equality Act. The Assembly passed all 10 points proposed by the governor at the June 4 rally and lobby day. The Women's Equality Act includes provisions that will help close the wage gap, end workplace discrimination, and protect victims of domestic violence.

THE ONE THING YOU MUST DO...

The interest rate on certain federal student loans doubled on July 1. Contact your Representatives to support passage of efforts to retroactively set the rate at 3.4%, the rate in effect for the last year.

PENTAGON MOVES TO ALLOW WOMEN IN COMBAT ROLES

The Associated Press reported recently that the Pentagon plans to start training women as Army Rangers by mid-2015 and as Navy Seals by mid-2016. The Pentagon released its plans for ending the longstanding combat exclusion at the end of June.

FOLLOWUP ON TWO RECENT SUPREME COURT DECISIONS

With regards to the two cases cited AAUW will work to ensure Congress develops bipartisan responses to protect the rights of employees and voters. You may remember that the Lilly Ledbetter Fair Pay Act was a direct response to a 2007 Supreme Court decision – AAAUW joined with interested groups and Lilly in fighting for congressional action.

- Vance v. Ball State University: The court <u>redefined</u> the meaning of "supervisor" in a
 way that frees employers from responsibility for sexual harassment committed by
 employees who do not have the power to hire or fire.
- Shelby County, Alabama v. Holder: The Supreme Court struck down the section of the Voting Rights Act of 1965 that enables the federal government to monitor states with a history of voter discrimination more closely than other states
