## From the Board . . .

The Board met August 25<sup>th</sup> at the home of Bunny Jarrett for their annual organizing meeting. Present were Bunny Jarrett, President; Peggy Montgomery and Kristan McMahon, Co-Programs VPs; Kitty Richardson, Membership VP; Martha Trunk, Treasurer; Susan Conklin, Secretary; Becky Gaul, Communications Chair; Mollie Jewell, Book Sale Co-Chair; and Mellen Tanamly, Newsletter Co-Chair.

Programs: Peggy and Kristan reported that the theme for the September Branch meeting will be STEM. They have scheduled two speakers for the evening. For the October meeting, Melissa Jackowski, Grassroots Advocate from the National AAUW Office, will speak on AAUW issues and the November election. Members will be encouraged to advertise these meeting to friends and other organizations. The topic of the January meeting will be Human Trafficking. The meeting will be on Sunday, January 25, and it will be co-sponsored with the League of Women Voters (LWV) of Falls Church. Bunny and Peggy will apply for an AAUW-VA IMPACT Grant of \$100 to support this meeting. The Board agreed that we should communicate opportunities in the STEM area to members who can individually volunteer to support STEM activities of other branches and organization.

Membership: Kitty reported on a successful New Members Tea with five new members and twelve continuing members attending. Kitty supplied AAUW membership materials for the welcoming packets of all new teachers in the Falls Church City Public Schools in August. Kitty will be our representative at a table shared with the LWVFC at the FC Elementary Schools PTA Information Fair on September 9. Both organizations will distribute membership materials and information on voter registration.

Treasurer: Martha reported that we mad \$21,000 on the Book Sale with a profit of \$15,600. The profit will be divided 50% for the AAUW National Career Development Fund, 35% for Local Scholarships, and 15% for Special Projects. Martha reported on the revised policies concerning our 501(c)(4) that were presented at the Summer Leaders Meeting in July. Martha will write an article for the newsletter explaining the changes.

Book Sale: Mollie reported that Mary Youman's garage is ready for us to begin sorting books. We will sort on Saturday, September 6 and October 25. Books will be collected in bins at the Community Center from mid-September to mid-October. Mollie is organizing volunteers to work at the Taste of Falls Church, September 13. A seasoned member will pair with another member for each of the time slots.

Visioning Project: Bunny presented our work to date on the visioning process our branch underwent during the past year at the Summer Leaders Meeting. A sub-committee of Bunny, Susan, Mollie and Anne Baxter will develop Action Steps for each of our goals so that we can monitor our progress over time.

## AAUW Fundraising Policy

AAUW has issued a clarification on fundraising policies for the states and branches. The primary issue for the branch is that we are a 501(c)(4). This means that contributions to the branch are not tax deductable even if used for local scholarships. Contributions to our Career Development Grant, which are managed by AAUW headquarters, are tax-deductible. On the memo line of the check, you should indicate that it is for "The Falls Church Area Branch CDG #4350".

Another change is that we must clearly indicate the percentage of the donation that is taxdeductible. Local Scholarships, in which our members pick the recipient(s), and Special Projects are not tax-deductible. So book donations are only 50% tax-deductible and all receipts should indicate that percentage.

The board has agreed unanimously that we should limit the donation percentage to 50% so that we can maintain our branch control of awarding the local scholarships.

There is also a prohibition about raising funds for another organization. Monies given to other organizations, like Aurora House or AVID, are not funds raised for them but rather donations in support of their programs, which also meet our goals.
