#### From the Board . . . .

The Board met November 24th at the home of Mollie Jewell. Present were Bunny Jarrett, President; Kristan McMahon, Co-Program VP; Kitty Richardson, Membership VP; Martha Trunk, Treasurer; Susan Conklin, Secretary; Mollie Jewell, Book Sale Co-Chair; Becky Gaul, Communications; and Pam Martinov, Newsletter Co-Editor.



**Programs:** Kristan reported that the November branch meeting at Jimmy Potters was a fun and resulted in many attractive pieces of pottery by our members. Although only a small number of members attended, they raised \$147 for our Branch!

The January 25 meeting on Human Trafficking is being co-sponsored by the LWV of Falls Church and The Commission on Women. Other co-sponsors may be added. A flyer about the meeting will soon be available for distribution.

The Holiday Party is Sunday afternoon, December 7 at Bunny Jarrett's house.

Kristan reported that she has had no interest in a performance before the party, so we will not have this option this year. Members of the Board volunteered to call each member with an invitation to the party and to find out who will attend. They also volunteered to bring food and drink to the party.

**Membership:** Kitty reported that we have 41 paid members and four Life members. Those who have not renewed their membership have been contacted by Kitty and other board members. November 30 is the last day to pay dues before members are removed from the rolls. Kitty continues to explore the diversity issue by attending a meeting at the Unitarian Church and investigating activities we might pursue for Black History Month.





**Treasurer:** Martha reported that members who have not paid dues by November 30 will be removed from National and Branch rosters. The book sale balance is \$17,25.00. Our branch bank account has \$1,192.06. Martha will include the donation from an anonymous donor as part of our payment for the Career Development Fellowship. Martha met with the Subcommittee on Corporate Donations, Susan Hesser and Christiana DeJong. Several possible fundraising strategies were discussed. Caroline Pickens will join them for their next meeting to address tax exempt status and other issues.

**Book Sale:** Mollie presented a prototype of a table sign for the Book Sale that she and Mary Youman have developed. The Board was enthusiastic about the new sign format and agreed that Mollie should follow through with production of the signs. Book collection will begin again in March 2015.

**Public Policy:** Bunny indicated that we need to continue to get signatures on the AAUW-VA petition to the VA Legislature to address victims of Human Trafficking. Kristan had hard copies of the petition at the November meeting and will have it available at the December Holiday Party. Kitty plans to attend the Legislative Roundup in Richmond in December.

Computer Science Education Week Proclamation: At the request of AAUWFC, the Falls Church City Public Schools (FCCPS) School Board declared December 8-14 Computer Science Education Week at their meeting November 18. Eight Branch members attended the meeting and were recognized by the Board. The proclamation was facilitated by AAUWFC member Marybeth Connolly.

**Communications:** Becky is still looking for volunteers to submit notices of our activities and events to various media outlets. The Branch member roster has been updated.

**Book Group:** Book Group thanks Nancy Fulwiler for hosting a wonderful meeting on November 18th, based on <u>The Smartest Kids in the World and How They Got That Way</u> by Amanda Ripley. Nancy invited three guests whose participation really enhanced our discussion of global education: Karin Tooze, an IB English Literature teacher at Geo Mason High School; plus Foreign Service friends Setsuko and Kanako, who both taught and attended school in Japan. We had a lively discussion about education in the US, comparing US secondary schools with those in Japan, and why Finland, South Korea, and Poland outscore the US on the PISA test. We learned from each other, enjoyed international snacks, and look forward to future conversations.

The next Board meeting will be Tuesday, January 13 at the home of Martha Trunk.

## **AAUWFC Spearheads Computer Science Education Week**

The Falls Church City Public Schools (FCCPS) Board passed a resolution at their November 18 meeting that announced December 8-14 as Computer Science Education Week. This resolution was adapted for local use from a sample created by the staff at National AAUW. Our Falls Church Branch asked the School Board to adopt the resolution. Several Branch members were present at the School Board meeting and stood to hear the resolution along with two FCCPS teachers. The process was facilitated by Branch member Marybeth Connelly of the FCCPS's Business and Community Partnerships and a member of the Falls Church City Council.

The Computer Science Education Week resolution will draw attention to the importance of offering computer science education in all levels of our public school curriculum. The resolution will be announced in the School's Morning Announcements the week of December 8-14 and will be shared with teachers and administrators and the community.

# **AAUW of Virginia Petition Drive on Human Trafficking**

Human trafficking is an international disgrace. It forces an estimated 27 million people world wide into prostitution or involuntary labor. The National Human Trafficking Resource Center (NHTRC) reports that it received 742 phone calls from individuals seeking help in Virginia in 2013—the sixth-highest number of calls among all states and Washington, D.C., that year. Despite the wide scope of the problem, Virginia's laws do little to provide assistance to human trafficking survivors. The Polaris Project, which runs the NHTRC and tracks federal and state laws

on human trafficking, recommends that Virginia pass laws to provide assistance to human trafficking survivors, including creating "safe harbors" for sexually exploited minors. In response, AAUW of Virginia has embarked on a petition drive with a goal of collecting at least 1000 signatures in support of legislative action by January 30, 2015. These petitions will be presented to lawmakers in Richmond on February 4, 2015, AAUW's State Lobby Day. Your help is needed to reach and exceed this goal. ## **Diversity Dialogue**

The diversity subcommittee continues to work on expanding experiences. The goal is to become more aware of opportunities presented in our daily lives with "new eyes". Currently we are seeking ways to learn more about our sisters from different cultures and to let them get to know us/our organization.

A vital member of the subcommittee, Elizabeth Kessel, says: "We are using structures already in place to encourage our sensitivity to diversity. Members of the film group went to see 'Dear White People', directed by Justin Simien. It is a comedy, set at a liberal arts college, that satirizes college manners and attitudes which reflect racism.

The book group read <u>The Smartest Kids in the World and How They Got That Way</u>, which shows how other countries encourage their student excellence. Nancy Fulwiler had friends from Japan discuss education in Japan. Snacks served were from various countries (Finland, South Korea and Poland) with high-performing educational systems. Even though the next book selection is an American Classic, <u>The Adventures of Huckleberry Finn</u>, we are reading it because the Iranian author, Azar Nafisi, sees Huck Finn as embodying defining American characteristics."

# **Introducing Mary Ellen Gannon**

Mary Ellen Gannon recently retired from her career as teacher and nurse so has decided to share some of her time with our branch.

Mary Ellen grew up in the suburbs of Boston. As a young married woman she lived in St. Louis, MO then moved to the Washington, DC area in the 1970s.

Mary Ellen received a BS in Nursing from Boston College. As her three children were growing up she worked a flexible schedule at Arlington Hospital (now Virginia Hospital Center) at first as prn (as needed), then part time and finally full time. Her career led to specializing in intensive care nursing then to administration. She decided to get her Masters in Education at

Marymount University which prepared her for teaching which she loved. At one point she was involved in a collaborative program with No. VA Community College and other institutions to introduce students to various occupational opportunities in health care.

Fourteen years ago the Virginia Hospital Center's Medical Brigade was formed in response to a devastating hurricane in Honduras. Mary Ellen joined the effort in its second year and every year since then. Personnel, equipment and supplies are transported to Honduras to provide surgery, medical care and rural clinic outreach services. In recent years clean water and inhome air quality have been a focus. One of the Brigade's volunteers noticed that the female members of households suffered a much higher incidence of respiratory symptoms than the men. Further investigation identified that smoke from in-home stoves was the culprit. A "smokeless stove" project ensued to provide top vented replacement stoves which improved the quality of both air and respiratory health. The study was recently published in a medical journal.

Mary Ellen heard about AAUW from Bunny Jarrett. She was impressed with AAUW's printed material which profiled areas of great interest to her – specifically girls mentoring and scholarship programs and women's rights. Mary Ellen says is looking to AAUW as an "opportunity to participate in meaningful activities". She already accepted Bunny's invitation to help with interviews of high school student candidates for volunteer positions.




#### Book sale on winter vacation:
