AAUW Lobby Corps to Hold Training

Are you interested in public policy and having a meaningful and significant impact on legislation pertaining to issues of concern to women and their families? If so, you're an ideal candidate to join the AAUW Lobby Corps. Lobby Corps is made up of AAUW members in the metro area who meet with Members of Congress and/or their staffs on a regular basis to share AAUW's position on legislation that affects women. Typically, Lobby Corps meets Thursday mornings when Congress is in session. Members are briefed both with written materials sent out on Wednesday and orally by AAUW staff on Thursday morning. After the oral briefing and time for questions Thursday morning, members break into pairs and then visit 5 to 7 offices, typically finishing around noon. She was accompanied and introduced by Edgar Aranda-Yanoc, an immigrant himself, who is now the Chair of the Virginia Coalition of Latino Organizations, with a specific concern for the Legal Aid Justice Center's Immigrant Advocacy Program.

Giancarla's story is one of persistence, meeting and overcoming the many obstacles presented Falls Church Flash

to young people who find themselves with major barriers to their ambitions due to their lack of documentation, yet who have spent their school years here and know little of the countries from which their parents came. They have taken advantage of this course offered by President Obama, yet know that this opportunity can be taken from them in the new administration.

These young people, with the support of people like Edgar Aranda-Yanoc, are trying to plan a course of action that will take this uncertainty from them. We wish them well and will keep them in mind as we plan post-book sale projects.



Here is a brief description of the Jan. selection "The Distracted Mind":

Most of us will freely admit that we are obsessed with our devices. We pride ourselves on our ability to multitask--read work email, reply to a text, check Facebook, watch a video clip. Talk on the phone, send a text, drive a car. Enjoy family dinner with a glowing smartphone next to our plates. We can do it all, 24/7! Never mind the errors in the email, the near-miss on the road, and the unheard conversation at the table. In *The Distracted Mind*, Adam Gazzaley and Larry Rosen--a neuroscientist and a psychologist--explain why our brains aren't built for multitasking, and suggest better ways to live in a high-tech world without giving up our modern technology.
