Co- Presidents' Message



Dear All,

Here we are at the beginning of September. Despite the current high temperatures and humidity, fall is just around the corner. And now we begin the final two-month dash to an important election on November 3. Remember: if you need to update your voter registration or if you want to get an absentee ballot don't have wait in lines this November, so that you to go to https://vote.elections.virginia.gov/VoterInformation and click on whichever task you want to accomplish. You will need your Social Security Number and your driver's license number, but it's all pretty simple and you no longer need a special reason for requesting an absentee ballot. If you do want an absentee ballot, request it right away, so that you can get your ballot in time to fill it out and return it well before Election Day; you don't want to go to all that trouble and then lose your vote because you missed a deadline.

We recently celebrated the centennial of passage of the 19th Amendment in 1920 — an event that only took 70 years of hard work and dedication! There were many heroines in that long campaign who fought prejudice against women, and some who had to fight prejudice against Black people as well. The suffragists were often jailed when they protested, and they were famously force fed when they went on hunger strikes to protest being treated as criminals and not as political prisoners. Some even died for the cause.

And yet, they persisted — and eventually won!

A hundred years later, much remains to be done. Women still earn less than men in comparable jobs. Women have been elected to many more political offices today than in the past, but their number falls far short of representation comparable to their proportion in our population. And while we in Virginia achieved passage of the resolution ratifying the ERA Amendment, it remains unclear whether this crucial 38th state ratification will be acknowledged and the amendment brought into force.

All of which is to say that your vote matters. As an organization, we are working to encourage maximum participation in this year's election. Mollie Jewell is coordinating a postcard writing campaign to increase voter registration among underrepresented groups.

Meanwhile, Bunny Jarrett is coordinating a joint effort with the League of Women Voters to encourage establishing a nonpartisan process for redistricting in Virginia. Politically and racially-based redistricting has



been one way in which political parties have frustrated the intent of the Voting Rights Act, to make every individual's vote count. Too often, districts have been drawn to make each of them a safe seat for one party or the other, making elections all but irrelevant.

So let's continue the struggle together, and achieve our next successes in fewer than 70 years!

Dear Suzanne,

The AAUW Board of Directors will consider and vote on a change in Individual Member dues at their upcoming Board meeting on October 16, 2020. Any increase would take effect on July 1, 2021. The Board will consider two different options:

A. An increase to take effect on July 1, 2021, of an amount between \$3 and \$10.

B. An increase to take effect on the 1st of July of each of the next three fiscal years of between \$3 and \$10 each year.

The selection of option A or B and the exact amount of the increase for the option chosen will be determined by the board at its October meeting. Any change to Individual Member dues will impact paid Life Membership as well, since AAUW's bylaws require paid Life Membership to equal 20 years of annual dues. The Board is not considering a change to College/University Member dues at this time. Membership dues cover between 15% and 20% of AAUW's annual budget. While AAUW's expenses increase annually, in recent years dues have not increased with enough regularity to keep pace with expenses. Increasing Individual Member dues will help AAUW cover more expenses, including important functions like the Connect team, critical technology and infrastructure such as the website and Member Services Database, and other member support.

Please send any comments regarding this dues increase to <u>connect@aauw.org</u> no later than Friday, September 25, 2020. All comments will be reviewed by AAUW staff and the Board of Directors prior to the Board's vote. Thank you.

Two Opportunities to Speak Up on Issues and Make a Difference

FIRST: Educate Voters Regarding Virginia's Constitutional Amendment to Improve the Redistricting Process in Virginia by Writing Postcards. Falls Church Area AAUW coordinates with the League of Women Voters of Falls Church. Read more below and contact Bunny Jarrett at <u>mjarrett@gwmail.gwu.edu</u>.

Every ten years, all 50 states redraw their electoral district lines. In Virginia, this responsibility rests with members of the General Assembly. In this November's election, voters have a chance to end partisan gerrymandering by approving a constitutional amendment to create Virginia's first-ever



redistricting commission. Both AAUW of Virginia and the League of Women Voters support the adoption of the ballot referendum that, if approved, would amend the Virginia Constitution to establish a Virginia Redistricting Commission. The Redistricting Commission would be made up of eight legislators and eight citizens, with a citizen chair. The Commission would require citizen participation and transparency in the redistricting process. AAUW-FC is collaborating with the LWV of Falls Church to write postcards to educate voters about the proposed Virginia constitutional amendment to improve the redistricting process. SECOND: Educate Voters Regarding Voting, Voter Registration and Re-Registration by Writing Postcards.



AAUW-FC is engaged in Reclaim Our Vote (ROV), a postcardwriting project of the Center for Common Ground of Virginia, a registered non-partisan 501(c)3 organization. Read more below and contact Mollie Jewell at <u>molliejewell2@gmail.com</u> ROV is a project of The Center for Common Ground of Virginia, which works with national partners, including the NAACP, Black Voters Matter, Mi Familia Vota, VoteRiders and DemLabs. AAUW-FC undertook this project both in memory of Kitty Richardson, an

active civil rights supporter and our diversity chair, who passed away this winter, and in support of AAUW's public policy priorities to increase voter turnout and to promote diversity and inclusion. As of August 3, 2020, our branch members and friends and family have colorfully handwritten 1600 postcards, reaching 1600 potential voters. We are continuing this project. Members began writing their second round of postcards in mid-August.

***AAUW's 2020 Gender Policy Agenda recognizes that voting is a Foundational Right and includes an objective to "Expand and Protect the Right to Vote. AAUW stated that elected officials should protect and expand voting rights, automatic voter registration should be established, early and online voting should be promoted, and partisan gerrymandering should be ended by creating non-partisan redistricting procedures.

We've already written 2,700 postcards, and Mollie has raised the goal to 5000! (Members have time for a couple of rounds before October). And, as always, friends and family are welcome to help!

More on Postcards!

Thank you to all who have volunteered to write postcards about redistricting reform with the League of Women Voters of Falls Church. I have received some postcards from the LWV coordinator and am waiting for more so I can distribute them to our AAUW members. I also have asked for lists of names and addresses to which we can send postcards. I asked for voters outside the Northern Virginia area because I think other areas of the state will receive less education about the proposed redistricting amendment. I expect to have the postcards and names and address the week of August 31 and will get them to you as soon as possible. Thank you for your patience.



Did you know that 100 years ago today, the Nineteenth Amendment to the US Constitution was ratified? This historic amendment prohibits states and the federal government from denying the right to vote to citizens of the United States on the basis of sex, and represents a tremendous step forward on the long road to creating a more just, fair and equal United States.

In recognition of the history of August 26th and National #WomensEqualityDay, we want to highlight two nonpartisan partners that have endorsed <u>Amendment 1</u> and have been supporting democracy, women and girls for over 100 years!

The <u>League of Women Voters</u> mission is: "Empowering voters. Defending democracy." Securing the passage of Amendment 1 is critical to this mission in Virginia. Deb Wake, President of the League of Women Voters of Virginia, <u>states</u>: "Gerrymandering is voter suppression. We have an opportunity to provide a framework for fair redistricting that can serve as a model for other states. The proposed constitutional amendment gives the citizens of Virginia a chance to offer input for the first time in our history."

LWV Wins Election Lawsuit

On August 21, the League of Women Voters of Virginia received a favorable ruling in federal court in its lawsuit which sought to suspend the requirement that a voter casting an absentee ballot have a witness observe and sign the ballot envelope. Due to concerns about the ongoing COVID-, the LWV-VA had filed the lawsuit to remove a barrier to voting for individuals who might worry about jeopardizing their health in order to locate a witness to sign their ballot.

Mosaic of Suffragist Ida B. Wells



A 1,000-foot mosaic of Ida B. Wells made of non-slip vinyl was displayed on the floor of Union Station the week of August 25. The art installation was commissioned by the Women's Suffrage Centennial Commission to commemorate the 100th anniversary of the 19th Amendment. The mosaic was created using photographs of 4500 suffragists, along with images of memorabilia from the suffrage movement. Wells, a black woman, was a crusading journalist who used her talents to expose the

inequality and violence experienced by people of color. She was also active in the fight to obtain the vote for women, marching with her fellow Illinois delegates in the 1913 suffrage parade in Washington, D.C., rather than at the back of the procession as many white members of the movement wished her to do. Voting in Virginia

In this year when we are celebrating the 100th Anniversary of Women's Suffrage, it is important for all of us to exercise our right to vote. AAUW of Virginia has produced a handy flyer with important dates for the November 3 election and a link to the portion of the Virginia Department of Elections website (elections.virginia.gov) which relates to that specific issue, such as absentee voting. A copy of the flyer follows this article.

The General Assembly passed several pieces of legislation this year that expand access to voting for Virginia voters. These include: no-excuse voting by mail or in person, elimination of the requirement for a picture ID at the polls, and implementing automatic voter registration when an individual accesses service at a Department of Motor Vehicles office or on the website.



There are three ways to vote in November: 1) In person on November 3; 2) Absentee by mail; 3) Early in-person at your local registrar's office starting September 18. If you plan to use option 2 and vote absentee by mail, it is recommended that you apply for your absentee ballot immediately and that you complete it and mail it to or drop it off at your local registrar's office or another place designated by the registrar soon after you receive it. Absentee ballots will be mailed out beginning September 18. A large number of Virginians are expected to vote absentee by mail this year, and with the challenges faced by the U.S. Postal Service, extra time will be needed to make sure your ballot arrives in a timely manner.




Our fall finale in November will be **The Old Guard**, an American superhero film based on the comic book of the same name. It can be watched through Netflix Streaming.

Members of AAUW Mount Vernon have been galvanized by the events that occurred in our country after the murder of George Floyd. We want to learn and hear what we need to know in order to be a part of the change that is necessary.

To that end, AAUW Mount Vernon and Sherwood Regional Library, have invited **Queenie Cox** to share what **The Black Experience in Mount Vernon** is like. Queenie Cox was born and raised in Gum Springs, the oldest African American community in Fairfax County. She's a community activist striving to improve the quality of life for Gum Springs residents at the same level as other communities in Mount Vernon.

Queenie will be interviewed by **Joi Jackson**, Information Services Librarian at Sherwood Regional. Topics of discussion will include self-segregation within the community; the impact of gentrification; and separate but not equal access to community resources and political influence.
