
Current officers will summarize their activities (July 1, 2019 – June 30, 2020) in an interim annual reports, and their written reports will be available for your review.

The Falls Church City Council is meeting Monday March 23, 2020, in the evening, to issue a proclamation recognizing that March 31, 2020 is "Equal Pay Day," the day that women, working the same job as a man, finally earn the same amount of compensation that the man earned as of December 31, 2019. We have asked the City Council to issue the proclamation, and Marilyn Faulksen has worked cooperatively with them to do so before March 31, 2020. Generally, the City Council prefers to take such symbolic actions at the beginning of their meeting. We would like the Branch to be well represented at the meeting, and have our picture taken with the proclamation and members of the Council. Please consider attending the opening minutes of the March 23 meeting (beginning at 7:30pm) to make a statement about the importance of gender pay inequity, and AAUW's historic role in advocating for pay equity.

We look forward to seeing you at the meeting and sharing a beer box with you at book sorting.





#### **Equality Celebration**

On Sunday, March 8, which is International Women's Day, VAratifyERA is sponsoring an Equality Celebration in Richmond, Virginia, to acknowledge Virginia making history for equal rights by becoming the 38<sup>th</sup> and final state needed to ratify the Equal Rights Amendment. The event begins at 3 p.m. in Monroe Park (620 West Main Street) with speakers and musicians. Participants will walk to the State Capitol for a photo session and return to the park (a total of 2.5 miles). During the parade, the story of equal rights will be told through four distinct eras:

(1) 1920 – 19<sup>th</sup> Amendment/women's suffrage; (2) 1970 -- Title IX; (3) 2020 -- Virginia's ratification of the ERA; (4) Future – when the ERA is added to the Constitution. Each section will tell a story through banners, parade puppets, and the participants wearing different colors for each era. #### Falls Church City Council to Issue Equal Pay Day Proclamation

On Monday, March 23, the Falls Church City Council will issue a Proclamation proclaiming March 31, 2020, as Equal Pay Day in the City of Falls Church. Equal Pay Day is the symbolic day on which the wages paid to women who worked full time finally catch up to wages paid to men the previous year. In other words, on average, it takes women 15 months to earn the same salary as men make in 12 months. All Branch members are encouraged to attend the Council meeting to show our support for the Council's action and to reiterate the importance of gender pay equity to AAUW. The Council meeting begins at 7:30 p.m. in the Council Chambers, Falls Church City Hall, 300 Park Avenue, Falls Church. The issuing of proclamations is typically the first order of business,

and Branch members will be free to leave once the proclamation is signed and given to our Presidents. They may, of course, stay for the entire meeting if they wish to do so.

#### Falls Church Women's Suffrage Centennial

The theme for the Women's History Walk in Falls Church this year is the celebration of the Centennial of Women's Suffrage; the Walk will occur on May 3 (rain date May 17). To further celebrate this Centennial, the Friends of the Women's History Walk have encouraged interested Falls Church organizations/businesses to hold events relating to this seminal event and has established a website with a calendar publicizing these special events. ## BOOK SALE 2.0



## SMARTSTART/ WORK SMART



As you are probably aware, AAUW challenged itself to train 100,000 people in StartSmart/WorkSmart salary negotiations by August 22,

2019. <u>https://salary.aauw.org/</u> AAUW also encouraged all members to take the training and spread the word. The training is still available and the ability to negotiate on one's own behalf is always important.

AAUW writer Beth Haynes, a member of the Board of Directors said: "I thought I didn't need the training. I've been out of the workforce for more than 20 years. But then I started thinking about all of the ways that training in negotiations could have helped me in the last couple

of years. I bought a new car. I helped my 93- year-old friend secure an apartment in an assisted living facility. I'm a certified parliamentarian and I have to negotiate contracts with groups who need parliamentary services. So, the negotiating training really is designed for me." And, she said, "It's probably designed for all of your members as well, regardless of whether they are in the workforce."


We encourage you to sign up at <u>https://salary.aauw.org/</u>. It doesn't take very long and it will pay off—personally for you and your friends and family who take the training.

Here is a brief description of our March selection: <u>Maid: Hard Work,</u> <u>Low Pay, and a Mother's Will to Survive</u> by Stephanie Land.

Evicted meets Nickel and Dimed in Stephanie Land's memoir about working as a maid, a beautiful and gritty exploration of poverty in America. Includes a foreword by Barbara Ehrenreich. "My daughter learned to walk in a homeless shelter." While the gap between upper middle-class Americans and the working poor widens, grueling lowwage domestic and service work--primarily done by women--fuels the economic success of the wealthy. Stephanie Land worked for years as a maid, pulling long hours while struggling as a single mom to keep a roof over her daughter's head. In <u>Maid</u>, she reveals the dark truth of what it takes to survive and thrive in today's inequitable society.
