Recap of January Meeting-ROV

On January 9th, Roxanne Rucker, regional organizer for the Center for Common Ground (CCG), spoke to us so we could learn more about those 11,000 non-partisan postcards we've written since 2020.



The Center for Common Ground (CCG) is a (501c3) organization whose mission is to educate and mobilize underrepresented people to fully participate in our democracy. Reclaim or Vote (ROV) is a popular project of CCG. That's how those 11,000 postcards we wrote with friends and family in honor of Kitty Richardson fit in with AAUW's public policy priority to "support open and fair elections that are broadly accessible to all voters."

Reviewing ROV activities so far, Roxanne cited the following highlights:

In 2020 overall, ROV/CCG contacted 14 million voters via 9.4 M postcards, 2.9 M text messages, and 1.7 M phone calls. For the presidential election, in the summer of 2020, 3,000 volunteers across the DMV wrote post-cards, texted, and phone banked. Effectiveness? 70% of GA voters contacted – voted. Most voted early. (Such statistics are not available everywhere.)

In 2021 ROV participated in efforts to counter voter suppression. AAUW-FC participated in AZ efforts. While states passed more restrictive legislation, still many bills failed. ROV/CCG also established the local Democracy Centers by partnering with community-based organizations. Activities included training on local elections/policies, identifying pressing issues, and connecting to local government. There are now 11 centers with a goal 40 across the southern states.

In 2022, ROV will focus on infrequent voters, getting them to exercise their "voting muscles." The effort will start next week for March primaries in 12 Texas counties. Postcards should be mailed by Feb 14, followed by phone banking and texting later. Other activities will include opening more Democracy centers and a Webinar series featuring officials and members of Congress.

Roxanne also responded to our many questions.

Q: Do you work only with Black organizations?

A. CCG/ROV works with both Black and other underrepresented groups. Most work partners with local organizations who are able to access lists of underrepresented voters. Targeting reflects the local partners' interests and the information they can get, so targets vary. Partners include Mi Familia Vota (Hispanic), NAACP state and city branches, and others.

Q: What are 2-3 impactful activities planned for 2022? Answer:

- Phone banking (more effective than post carding) and post carding
- Contact congress people and Senators about federal voting standards
- CCG Director Andrea Miller's webinar on emerging issues/topics.

Q: Describe training for phone banking.

A: Training happens 2 times per week, including "national guidance session," training on using phone bank tools and script, plus other training on Youtube.

Q: Budget for On Common Ground? Sources of income?

A: Private grants, foundations, philanthropists with a significant share from individual donations. Need help Let ROV know of any grant-raising institutions.

Q: What are voter registration suppression/barriers?

A: A primary concern is purging previously registered people from registration rolls. While not a problem in places like Arlington County, access to registration information can be an issue. Many smaller areas have poor websites. Also voter ID requirements and, during pandemic ID agencies/DMV may be closed or slower.

Book Sale?

Yes, the Falls Church AAUW Branch will indeed hold an April book sale, but it will in all likelihood be our last. So, here are very preliminary details; we ask you to watch for further messages as to just how we are going to pull it off, with the goal of raising a really substantial sum for our scholarship fund. The scholarship committee has done its best to see that graduating girls have received some help from us the last two years, but the funds have clearly been restricted by the absence of our book sale.



So: here goes!

Date: April 28 (set up day) to April 30 (celebration day!) At the usual place: Falls Church Community Center. We'll give you the exact hours as we establish them.

Sorting begins again on Saturday, February 26 at Willston Multicultural Center (directly across Arlington Blvd from Home Depot). We ask that you be there at 9:00, if possible, as our plan is to start receiving donations at 10, stopping near noon for donations, and as soon after as we can for you, our workers. These donation hours will be more limited than in the past, as we still have limited storage and need to sort carefully.

Contingent on agreement from Willston, we will sort on March 5, March 12, March 26, and April 2 and April 9. We will hold April 23 for finishing up at Willston. We will also have a large bin at the Community Center, but we hope to close donations there by April 9.

As in the past, husbands are really welcome during sorting days and set up day. We will be storing many books off site, and for loading those into a couple of cars and making that move to Public Storage would be a lot easier with the help of some men.

In the absence of a planning luncheon, which we might still be able to schedule, we will need your help to get the word out about both the sale and the donations—probably on reverse sides of our usual book marks, as well as signs you can help us distribute. The Farmers' Market may be our best pickup place for publicity materials—we'll let you know when we figure that out. We will also need you to indicate what jobs you can take on before and during the sale and at what times. That signup opportunity will definitely come to you in the next FLASH message.

We are excited about being back in the business again. Our December sales showed a lot of enthusiasm among Market visitors, and we hope they are just a start to all the folks we can get to buy our wonderful books. Our prices will be a little higher this year, which we hope will augment our earnings significantly.

Sarah John and Dianne Bodeen are leading this year's sale and are eagerly looking forward to having as many members as possible work with us. Watch for more information from us.

Public Policy

Virginia General Assembly Update

The 2022 Session of the Virginia General Assembly convened on January 12 and will meet for 60 days, adjourning on March 12. Crossover, when the bills passed by the House of Delegates are sent to the Senate for consideration and those passed by the Senate are sent to the House of Delegates for consideration, will occur on February 15. A bill must pass both the House and Senate with the exact same language before it is sent to the Governor for his consideration.

AAUW-VA is currently focusing on bills in three areas which directly address the needs of women and their families — paid sick leave, salary history ban, and paid family and medical leave. Here are the bills areas AAUW is currently supporting and their status.

Paid Sick Days: AAUW is supporting two House bills and two Senate bills, all of which would require employers to provide paid sick days to their employees. They differ on whom the bill covers. **HB 1160** and **SB 352** cover health care providers, grocery store workers and home health workers who provide agency-directed serves. (Last year legislation was passed that covered home health workers who provide consumer-directed services –



Medicaid.) **HB 997** and **SB 624** provide a slight expansion on last year's legislation and cover only home health workers who provide agency-directed serves. The House bills are in the House Energy and Commerce Committee Subcommittee 4, which has not scheduled action on them. The Senate bills are in the Senate Commerce and Labor Subcommittee on Labor and Employment, which has scheduled them for consideration on January 31.

Salary History Ban: SB 447 would prohibit an employer from requiring that a prospective employee



provide her salary history so that the employer could use that in determining the employee's salary. This bill is an essential step in closing the gender pay gap. The bill is in the Senate Commerce and Labor Subcommittee on Labor and Employment and is on the Subcommittee's agenda for January 31. **Paid Family and Medical Leave: SB 1** would require the Virginia Employment Commission to establish and administer a paid family and medical leave program. Prospects for this bill appear slim at the present time. Although not the same as **SB 1**, which establishes a *public* family and medical leave program, **HB 1156** and **SB 15** establish paid family leave as a class of *private* insurance, which would allow employers to purchase protection against the cost incurred from offering a paid family leave benefit to its employees. In states where private insurance plans exist, they have helped "change the culture" so



that businesses have become more accepting of paid family and medical leave programs. Currently, no businesses are opposing these two insurance bills. Finally, they are an example of bipartisan support with the House bill introduced by a Republican and the Senate bill by a Democrat. **SB 1** and **SB 15** are on the agenda for the Senate Commerce and Labor Subcommittee on Labor and Employment meeting on January 31. **HB 1156** is awaiting action by the House Energy and Commerce Committee Subcommittee 4.

Issue papers on all of these bills have been emailed to you, and you are encouraged to contact your legislators to let them know you support these measures. The issue papers include sample language to use when calling or emailing your legislators. Meeting With Women Legislators

In lieu of the Women Legislators' Reception, which was cancelled due to rising COVID cases, the AAUW-VA Co-Vice Presidents for Public Policy arranged a Zoom meeting on January 25 with 2 Senators and 2 Delegates, one from each party. Due to the busy legislative schedule, only Senator Mamie Locke from Richmond was able to attend. She began her presentation by explaining that a primary order of business would be the adoption of the State budget. Both the House of Delegates and the Senate will each have their own version, and they will need to be reconciled into one budget.



Senator Locke's No. 1 priority is passage of her bill, SB 21, a resolution to place on the ballot for the November 2022 election a Constitutional amendment making voting a fundamental right in the Commonwealth of Virginia. It also provides that convicted felons will be allowed to vote after they have completed their sentences without any further action on their part and changes the limitation on voting for people judged incompetent by a court to those who are judged by a court "to lack the capacity to understand the act of voting". The bill was voted out of the Senate Privileges and Elections Committee and is now pending in the Senate Finance and Appropriations Committee. Delegate Mike Cherry has introduced an identical bill (HB 130) in the House of Delegates; the measure is pending in the House Privileges and Elections Committee, with no action scheduled. Senator Locke

believes the bill will pass the Senate but has concerns about its fate in the House of Delegates. She urged those present to write to their delegates, asking them to work with their colleagues to see that the measure is passed so that the amendment can be placed on the November 2022 ballot, and Virginians can vote on this important voter rights measure. Getting a Constitutional amendment on the ballot is a long process. The amendment must be passed twice by the General Assembly with identical language each time, and an election must occur between the two votes. The amendment passed last year and must pass again this year to be put on the ballot.

In response to a question, the Senator stated that the mood in Richmond was "difficult" and feels that not much legislation would be passed by the General Assembly this year. She remarked that the Democratic Caucus has made the determination to act as a firewall against attempts to roll back the progressive legislation passed in the preceding two years. In her view, one bright spot of possible bipartisan action could be passage of SB 15 and SB1156, which were discussed above.

February 15-Science Fiction- Kindred by Octavia Butler



The first science fiction written by a black woman, *Kindred* has become a cornerstone of black American literature. This combination of slave memoir, fantasy, and historical fiction is a novel of rich literary complexity. Having just celebrated her 26th birthday in 1976 California, Dana, an African-American woman, is suddenly and inexplicably wrenched through time into antebellum Maryland. After saving a drowning white boy there, she finds herself staring into the barrel of a shotgun and is transported back to the present just in time to save her life. During numerous such time-defying episodes with the same young man, she realizes the challenge she's been given.
