



We are only as strong as our membership. If we want to make a difference and have an impact on policies that are important to us, we cannot let up on building our branch. Please help by inviting a friend to come to the January 8 or another upcoming program or an AAUW movie or book group. Consider asking a friend to join AAUW. Explain to your friends the many aspects of AAUW and the positive contributions of AAUW to the community, the state, and the nation.

Our state and national websites provide many examples of the value of AAUW. For example, recently, there have been many challenges to the curriculum taught in public schools, including Virginia public schools. AAUW of VIRGINIA has joined a coalition of non-partisan Virginia organizations and community leaders calling for the Virginia Board of Education to pass a curriculum proposal that was developed with state-wide community input. See the letter of the coalition calling for the VA Board of Education to pass the <u>August 2022</u> version of the proposed History and Social Science Standards of Learning and Curriculum. READ THE LETTER. AAUW supports truthful and balanced curriculum, which is the foundation of a quality public education.

Members can also let their policy positions and concerns be known through a valuable AAUW tool, the Two Minute Activist. Make a pledge to yourself and the FC AAUW branch to sign up and use this convenient way to make your policy views known to your legislators. By informing your legislators of your opinion regarding important legislation affecting women and girls, you can positively effect change. Currently, for example, AAUW urges all members to notify federal legislators to **Pass the Pregnant Workers Fairness Act,** which

would require employers to make reasonable accommodations to protect the health of pregnant workers. In AAUW's view, "This critical legislation passed the House of Representatives more than a year ago, but it continues to stall in the Senate. Tell our leaders that pregnant workers cannot wait another day." <a href="Take Action">Take Action</a> <a href="Now">Now</a>.

AAUW also sponsors many scholarships. AAUW's scholarships enhance the lives of the recipients and all who benefit more indirectly from AAUW's funding of higher education for diverse candidates. For example, see Gloria Blackwell's conversation with an AAUW Scholarship Alumna (2016-2017 Scholarship Award), Keisha N. Blaine (available on AAUW's website). Blaine is now an award-winning historian and *New York Times* best-selling author of *Until I Am Free: Fannie Lou Hamer's Enduring Message to America*. All of us who read Blaine's book are educated about an important, but lesser known, American civil rights intellectual.

Looking back, thank you, Susan Conklin, for a wonderful holiday party. We enjoyed the meal, conversation and camaraderie. Great choice! Thanks also to Mollie Jewell for collecting contributions at the lunch. In total, the FC AAUW branch members made a charitable contribution to The Center for Common Ground of Virginia, a registered non-partisan 501(c)(3) organization of \$225. Our contributions to this group, so important to encourage voter participation, are numerous – 18,390 postcards and counting! Thanks again, Mollie, for spearheading our engagement with this group.

#### First Meeting of 2023

We welcome the New Year with our first branch meeting of 2023 on **SUNDAY**, **January 8**, at The Falls Church Community Center at 2:00 p.m. We will meet with our elected representative to the Virginia House of Delegates, Delegate Marcus Simon. Del. Simon represents the 53<sup>rd</sup> House District, which includes the entire City of Falls Church and parts of Fairfax County.

Del. Simon is a lifelong resident of Fairfax County, where he resides with his wife Rachel, and two children, Emily and Zach. Early in his public service career, Del. Simon served as an officer in the U.S. Army Judge Advocate General's Corps, earning the rank of Army Captain, serving as a prosecutor and also as a part-time Special Assistant United States Attorney. He is a co-founder

of the law firm of Leggett, Simon, Freemyers & Lyon and EKKO Title, a real estate settlement, title, and escrow company.

First elected in 2013, Del. Simon currently serves on the following four House Committees: Courts of Justice; Finance; Public Safety; and Communications, Technology & Innovation. Del. Simon is proud of his work to expand voting rights, to protect our communities with commonsense gun violence prevention initiatives, to address the student loan debt crisis, and to prohibit discrimination based on sexual orientation or gender identity.

Murden, Co-VPs for Public Policy, AAUW of Virginia: The Virginia General Assembly session opens for its short 45-day session on January 11, giving us many opportunities to advocate for legislative, Policy, and budget priorities that advance equity for women and girls in the Commonwealth. It is the strength of our united voices that gets the job done, so we need every member helping in the ways they can.

We will kick off with a **Pre-Session Public Policy Zoom meeting on January 5 a t 5 p.m.** At this statewide gathering you will *learn how to advocate both in-person and virtually*. We will introduce you to tools and resources that will be available to our members throughout the session, highlight issues to watch for, and provide updates on our in-person Lobby Day plans for January 19 as well as how you can participate virtually. *This is one meeting you will not want to miss*.

We are in the process of planning a gathering in place of the reception, on Wednesday evening for those members who will be arriving that day as well as those who would like to join via Zoom.

They will be meeting with Delegates in groups of 2-3, using discussion points on AAUW issues provided by AAUW-VA Public policy. The 2023 Legislative Session is an important one, and your support and advocacy for AAUW-VA Policies and legislation will be critical. Here are the legislative priorities for 2023:

- Protect access to abortion and women's right to make personal reproductive decisions with their medical care providers
- Eliminate systemic racism and sexism through changes to Virginia law and regulations Make childcare affordable and readily available for all families
- Protect full access to voting
- Ensure full public-school funding and protect teachers from harassment and liability claims

#### **PUBLIC POLICY UPDATES**

#### **VA Abortion Rights**

Among the legislative priorities for AAUW in 2023 is to protect access to abortion and women's right to make personal reproductive decisions with their medical care providers.

Considering this, and with the upcoming Lobby Day approaching, we include this information from a December 19 Axios Richmond online article.



#### Virginia Governor Youngkin's

proposed budget, which was unveiled on December 15, 2022, includes \$50,000 to pay to incarcerate people who violate a 15-week abortion ban the Governor is <u>pursuing</u>. Governor Youngkin favors a state ban on abortion after 15 weeks of pregnancy and called on legislators to enact new restrictions on the procedure shortly after the Supreme Court's decision to overturn *Roe v. Wade*. The Supreme Court overturned *Roe v. Wade* on June 24 2022, in *Dobbs v. Jackson Women's Health Organization*. "The Supreme Court's decision, I agree with — that this is a decision for states to make by elected officials, by the citizens of Virginia," Governor Youngkin said on *Face the Nation* on July 10, 2022. The inclusion in the proposed budget of \$50,000 to incarcerate people

who violate a 15-week abortion ban is viewed as the opening salvo in the fight over abortion rights in the coming legislative session, which begins Jan. 11, 2023.

Legislators blasted Governor Youngkin for not mentioning or otherwise noting the proposed appropriation when he formally <u>presented his budget</u>. The allocation is required under procedural rules in the General Assembly, which require a minimum of \$50,000 in new corrections funding for any new laws that could increase the state's prison population. Governor Youngkins's press secretary, Macaulay Porter, defended the inclusion of the \$50,000 in the proposed budget stating that Governor Youngkin "will not sign a bill which imprisons women, that's pure political posturing." He also stated, "There is a technical requirement to include any legislation that may expand a felony in the budget, even before it passes."

Your voice is critical in protecting a person's right to make personal reproductive decisions with their medical care provider.

#### **Two-Minute Activist**

Become a two-minute activist and let your voice be heard on issues important to you and AAUW! It's easy. Just go to <a href="http://www.aauw.org/what-we-do/public-policy/two-minute-activist/">http://www.aauw.org/what-we-do/public-policy/two-minute-activist/</a> and click on the "sign up" button. This will bring you to a form to complete with your name, address, and email. Once you've signed up, you will receive email notices when your advocacy is most needed. AAUW will provide you with the tools you need to share your views with your Senators and Representative in Congress, your state legislators and other government officials. You will receive a prepared letter which you are able to modify to personalize if you wish. Then, with a push of a button, it's on its way. If time is of the essence, you may receive a request to make telephone calls and will be provided with talking points. With your help, the Action Network can continue to boost AAUW's influence on Capitol Hill and in statehouses across the nation


Let's Go to the Movies

## January 17<sup>th</sup>: *Merci Suarez Changes Gears* by Meg Medina Newberry Medal 2019


Thoughtful, strong-willed sixth-grader Merci Suarez navigates difficult changes with friends, family, and everyone in between in a resonant new novel from Meg Medina.


Merci Suarez knew that sixth grade would be different, but she had no idea just how different. For starters, Merci has never been like the other kids at her private school in Florida, because she and her older brother, Roli, are scholarship students. They don't have a big house or a fancy boat, and they must do extra community service to make up for their free tuition. So when bossy Edna Santos sets her sights on the new boy who happens to be Merci's school-assigned Sunshine Buddy, Merci becomes the target of


Edna's jealousy. Things aren't going well at home, either: Merci's grandfather and most trusted ally, Lolo, has been acting strangely lately — forgetting important things, falling from his bike, and getting angry over nothing. No one in her family will tell Merci what's going on, so she's left to her own worries, while also feeling all on her own at school. In a coming-of-age tale full of humor and wisdom, award-winning author Meg Medina gets to the heart of the confusion and constant change that defines middle school — and the steadfast connection that defines family.

### February 21<sup>st</sup>: *Deer Season* by <u>Erin Flanagan</u> 2022 Edgar Award for Best First Novel

It's the opening weekend of deer season in Gunthrum, Nebraska, in 1985, and Alma Costagan's intellectually disabled farmhand, Hal Bullard, has gone hunting with some of the locals, leaving her in a huff. That same weekend, a teenage girl goes missing, and Hal returns with a flimsy story about the blood in his truck and a dent near the headlight. When the situation escalates from that of a missing girl to something more sinister, Alma and her husband are forced to confront what Hal might be capable of, as rumors fly and townspeople see Hal's violent past in a new light.







### March 21<sup>st</sup>: *The Years* by Annie Ernaux, Alison L. Strayer (Translator) 2022 Nobel Prize for Literature

Considered by many to be the iconic French memoirist's defining work and a breakout bestseller when published in France in 2008.

*The Years* is a personal narrative of the period 1941 to 2006 told through the lens of memory, impressions past and present—even projections into the future—photos, books, songs, radio, television and decades of advertising, headlines, contrasted with intimate conflicts and writing notes from six decades of diaries.
