PUBLIC POLICY UPDATES

2023 Elections in Virginia

Although Election Day is November 7, early voting in Virginia has already begun. As mentioned in last month's *Flash,* every seat in the Virginia General Assembly is on the ballot, so this is a crucial election. It is vital that AAUW members vote for individuals that support AAUW-VA's public policy goals and encourage their friends, family and neighbors to do likewise.



Because of redistricting and an unusually high number of retirements this year, many candidates on the ballot in November may not be familiar to voters. To assist voters, AAUW-VA has prepared voter guides for all contested Senate races which show how the positions of the candidates in each Senate district stack up against AAUW-VA public policy priorities. These guides can be shared with voters in your community, are provided as a public service, and are not intended to be an endorsement of any candidate or political party. To access

these guides, go to https://drive.google.com/drive/folders/1cSSWPBTYJfXMEx1F4a8EIGo0BKpulp and click on your Senate District.

If you are not sure which Senate District is yours, go to https://whosmy.virginiageneralassembly.gov, fill in your address, and you will see your current State Senator and district number. Since most of the districts have been renumbered even if the current legislator is running, you will need to click on "new in ..." to see your new district number.

And remember, Be Sure to Vote and encourage your friends, neighbors and relatives in Virginia to do likewise. Every Vote Counts!



As mentioned in last month's Flash, Lobby Corps was formed in 1972; in the subsequent 50 years, Lobby Corps volunteers have made tens of thousands of in-person visits to congressional offices in support of AAUW's nonpartisan public policy priorities. Lobby Corps is AAUW in action!

AAUW members and college students in the Washington, DC area are welcome to join Lobby Corps. No experience is necessary, and Lobby Corps volunteers receive training on how to effectively advocate for AAUW's priority issues with elected officials. Lobby Corps meets on Capitol Hill on the third Thursday of each month (approximately two-hour commitment) when Congress is in session.

Lobby Corps is an essential source of accurate, timely information on issues impacting equity for women and girls.

- Advancing gender equity in education
- Supporting measures to improve women's economic security
- Curbing attacks on reproductive rights
- Advocating for the affirmation of the Equal Rights Amendment

NORTHERN DISTRICT SUMMARY

"AAUW's Public Policy and Advocacy Agenda: Get Informed and Be Engaged"

AAUW-VA's Northern District (ND) held its second meeting of the year on September 23, 2023. A total of 27 members representing 8 of the ND's 11 branches participated. The focus was on AAUW and AAUW-VA's public policy agendas and advocacy opportunities.

The meeting began with a video message from Congresswoman Jennifer McClellan. McClellan underlined her long support for and engagement with AAUW-VA as a Virginia state delegate and senator. She described her efforts since her election to Congress earlier this year to draft and/or sponsor legislation focused on AAUW's public policy priorities, including the Pregnant Workers Fairness Act, several childcare bills and the Paycheck Fairness Act. She spoke of her efforts to promote voting rights as well as to advance the ERA, noting that Virginia was the 38th and final state to ratify the ERA. She co-chairs the ERA Caucus on the Hill.

The Northern District had the honor to hear from Meghan Kissell, AAUW's Senior Director of Policy and Member Advocacy. She assumed her position in March 2023 and is already making a difference, including by regularly engaging State Public Policy Chairs and Branch Public Policy Chairs. While Meghan continues to focus on national level priorities in Congress, she also is working to engage branches working with state legislatures. She noted the recent passage of the Pregnant Workers Fairness Act, the introduction of the John Lewis Voting Act, and the Paycheck Fairness Act. While the latter has little prospect of passage in the current Congress, she urged us to continue to communicate its importance to our Members of Congress. This reinforces the "champions" of the bill and keeps it in the forefront. In this connection, she encouraged members to take advantage of AAUW's opportunities to convey views to legislators, e.g., Two-Minute Activist. Lobby Corps has also resumed on a monthly basis to advocate for these issues. Anyone interested in joining Lobby Corps should contact Kalina Majercak, AAUW Policy Associate (majercakk@aauw.org)

Title IX is another issue with a long AAUW history of action and advocacy. Stressing the importance of AAUW's nonpartisanship, she emphasized the importance of holding every U.S. Administration's "feet to the fire" and noted that the current Administration has been sitting on new Title IX rules.



There is new census data related to pay equity and ---- there is still a pay gap! Worse, Latina women have actually gone backward with their pay gap growing. In Virginia, overall women make 80 percent of what White men make. Women without a college degree are making only 59 percent. Meghan noted that there has been some good momentum at the state level (nationally) on salary transparency and salary history. (Note: We have work to do in Virginia!)

Finally, she said there is more momentum on the ERA now than ever before. There is an ERA Caucus on the Hill.

Our second speaker was Janine Greenwood, Reston-Herndon Area Branch, and Co-Vice President for Public Policy, AAUW-VA. Janine stressed the importance of the upcoming Virginia legislative elections in November

and the confusion that has arisen as a result of redistricting and legislator retirements. She described the work she and her member helpers have done to produce voter guides for the contested Virginia Senate seats that will be on the ballot. These guides address several key public policy priorities that have come up in the VA General Assembly. Incumbent voting records were used where available. Election websites and other sources were used for information for new, first-time candidates. The guides are for information only and do not constitute endorsements or opposition. The guides are posted on the AAUW-VA website. Attached to this report is a list of "Save the Dates" for the 2024 legislative year.

Both speakers entertained a number of questions and discussion.

The meeting ended with branches providing information on their upcoming programs, especially those open to other ND branch members.

Finally, thanks to those who brought diapers and baby wipes to donate to Generation Hope and Women Giving Back. These items are much needed and will make a difference in the lives of the mothers who receive them.

AAUW members faced violence to fight for civil rights in 1964 Freedom Summer in Mississippi!

They were called "communists" by segregation supporters.

A new play *Wednesdays in Mississippi* dramatizes the little-known activism of an inter-racial alliance of women who fought for civil rights in the South in 1964. Enraged at the exclusion of women from the 1963 March on Washington, Dorothy Height, director of The National Council of Negro Women, invited Northern women to join Mississippi women to struggle for voting rights, to support the Freedom Schools, and to aid the Mississippi Freedom Democratic Party.

The "Wednesdays in Mississippi" coalition, which included the **AAUW** and the League of Women Voters, formed the only women's civil rights project led by a national organization.

Written by Nicole Burton, Wednesdays in Mississippi is produced by Pipeline

Playwrights. Burton adapted the play for the stage from Debbie Z. Harwell's award-winning book by the same title. The November 11 performance will include a post-show discussion.

Who are the Pipeline Playwrights?

Pipeline Playwrights strives to break through the glass ceiling women face in the American theater when they try to get their plays produced. The group of five mid-career women playwrights aims to close the theatre gender gap one play, one reading, one production at a time.

Pipeline Playwrights is based in Fairfax County, Virginia, and the digital world.

In 2018, Pipeline Playwrights launched "Our Time, Our Stories," a multi-year project to produce five new full-length plays. After the pandemic hit, Pipeline quickly pivoted to Zoom and presented dozens of online readings and events, including a full production of the first play in the "Our Time, Our Stories" series, Ann Timmons' *A Very Present Presence*. In 2022, Pipeline began producing live plays again (*Heartland* by Patricia Connelly and *Unprotected* by Jean Koppen) but is committed to continuing to serve audience members unable to attend live theater because of disability, caregiving responsibilities, or economics.
